KRI Course Completion Requirements

I, the undersigned, agree to the following:

1. KRI and the KRI Teacher Training team reserve the right to grant KRI Level One certification based solely on their discretion and evaluation of each student's readiness to be a Kundalini Yoga Instructor. This evaluation is based on successfully meeting the course requirements including, but not limited to those listed in this document.

2. I understand that if for any reason I do not complete all of the requirements for certification, as listed above (with the exception of 20 Kundalini Yoga classes and one day of White Tantric) within 6 weeks of the conclusion of the course, I will be required to pay a **\$26 per month late fee**. All requirements including any accrued late fee(s)

must be received **no later than 12 months after the conclusion of the course**. If you do not complete the requirements for the course and submit the late fee within this timeframe you will not be certified.

3. If I am not granted certification, I understand that I have the right to appeal to KRI, whose decision shall be final.

DEPOSIT: \$1,000 due by March 8, 2012.

PAYMENT PLAN: \$3,225.00

\$1000.00 deposit due with this form by March 8, 2012. Due in nine-\$247.23 installments by post dated checks. Please write checks for the 15th of each month, April – December. The first payment must be received by the first day of the course, April 21, 2012. The remaining payments are due on the 15th of each following month (through December) and will be deposited automatically with the post dated checks.

Course fees break down as follows

Tuition: \$1,995.00

Books, Materials & Licensing Fees: (required) \$1000.00

Your course fee includes:

- 200 hours of classroom instruction over the course of eight months (one weekend a month)
- Membership in the International Kundalini Yoga Teacher's Association (IKYTA) Certification as a Level 1 Instructor requires Associate Membership in IKYTA, which is included in your registration fee. Once you have received your Level 1 Certification, you will automatically be upgraded to a Professional Member of IKYTA and listed in the Teacher's Directory online, and in the Aquarian Times magazine to receive referrals for your Kundalini Yoga Classes.

You are responsible for attending and paying for:
